· A.	Call to Order/Welcome/Introductions. Chair Wehbe called the meeting to order at 10:30am. John Adams from Andrews Global Security Service introduced himself, and he also introduced Jose Gomez with Andrews Global.
В.	Public Comment for items not on Agenda – None.
C.	Approval of Meeting Minutes. Thursday, December 20, 2018 Safe Committee meeting. Anabel mentioned a few spelling errors and Omahen said he would make corrections. On a Motion by Bass, seconded by Cassella, the Safe Committee voted to approve the Minutes, with spelling corrections, from Thursday, December 20, 2018 Safe Committee meeting. Anabel abstained due to absence.
D.	Andrews Global report. Adams reported all is going well. He also reported that they are working on a tracking system for the BID Patrol Officers to use, and that would include logging all calls for service. Bass asked about documenting and tracking problematic homeless individuals, and Adams said this would be added to the system. There was discussion regarding the increase of homeless individuals near to the new proposed homeless bridge housing shelter in Hollywood.
E.	LAPD Update. – Hernandez reported he has spoken with the manager of Walgreens, located at the corner of Santa Monica Blvd. and N. Highland Ave., about the manager's concern about shoplifting in his store. Hernandez said the manager has been calling the BID Patrol about the shoplifting, and Hernandez explained that this is inside the store and the BID is not able to address that. Hernandez also mentioned that the manager has not been calling the Hollywood Police, nor has the manager been reporting the shoplifting to the Police Department. Hernandez and Officer Jordan will be meeting with Walgreens to get their own on-site security guard to address the shoplifting problem.

 Hernandez reported that the Hollywood PD Division will be putting 16 to 20 more Police Patrol Units out on the streets beginning Jan. 20th. He said the Officers are already at the Hollywood Station and are just being reassigned.
