#### 4. 7-11 Nuisance Abatement Proceeding

The revised 7-11 Nuisance Abatement letter was approved at the Board of Directors on Thursday, July 23, 2020 recommending that (a) the sale of alcoholic beverages be prohibited and (b) a security guard must be present during operating hours. The case has been stayed because of a public record request made by 7-11. The hearing is expected to be rescheduled for October or November 2020.

# 5. Speed Bumps and Cross Walks

Padilla is working on having Speed Bumps and a mid-block Cross Walk installed on Sycamore Avenue since it has become more and more pedestrian friendly with restaurants and new businesses opening. A mid-block Cross Walk is being proposed because the new parking structure that was built is on the East side of Sycamore Avenue and most of the retail businesses and restaurants are on the West. This will avoid people randomly jaywalking.



# 6. Al Fresco Dining Permit

Padilla discussed the process of obtaining a permit for temporary Al Fresco outdoor dining through the City of Los Angeles. Al Fresco dining is a program aimed to help local businesses reopen their restaurants during the recovery phases of Covid-19. Customers and employees must follow strict physical distancing requirements that have been recommended by public health officials.
